

**ARTICLES OF ORGANIZATION
OF
KOPRI SIGNS & GRAPHICS, L.L.C.**

The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under the Alabama Code Sections 10-12-1 to 10-12-61, do hereby adopt the following Articles Of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

Kopri Signs & Graphics, L.L.C.

SECOND: The Limited Liability Company shall continue until the occurrence of an event set forth in the Operating Agreement which causes the termination of the Limited Liability Company.

THIRD: The Limited Liability Company is organized for the following purposes: any lawful purpose including, but not limited to the manufacture of advertising and promotional material; and to carry on any other activities necessary to, in connection with or incidental to the foregoing, as the Managing Members in their discretion may deem desirable.

FOURTH: The street address of the initial registered office of the Limited Liability Company in Alabama is 3607 Stratford Lane, Birmingham, Alabama 35242, and the name of the initial registered agent of the Limited Liability Company in Alabama at that address is Shailesh J. Shah.

FIFTH: The principal place of business of the Limited Liability Company is 3607 Stratford Lane, Birmingham, Alabama 35242.

SIXTH: The Limited Liability Company is to be managed by the Managing Members. The names and addresses of the initial Managing Members are: Shailesh J. Shah and Samata S. Shah, 3607 Stratford Lane, Birmingham, AL 35242. The Managing Member shall remain as Managing Members until successors are duly appointed only under the terms of the Operating Agreement of the limited Liability Company.

SEVENTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Managing Members, in accordance with the terms and conditions of the Operating Agreement of the Limited Liability Company.

EIGHTH: The remaining Members of the Limited Liability Company, by the affirmative vote or consent of Members holding a majority of the Members' Percentage Interests (other than the Managing Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.
