**MEMORANDUM OF AMENDMENT TO . . .  
CABLE TELEVISION INSTALLATION AGREEMENT**

WHEREAS, an Easement was granted by Crystal Tree I Limited Partnership ("Grantor"), to Shelby Cable Inc., A/K/A Shelby Cable TV, Inc. ("Grantee") under that certain Cable Television Installation Agreement (such Cable Television Installation Agreement, including the Addendum attached thereto, is hereinafter called the "Agreement") dated May 1996, as evidenced by that certain Memorandum of Cable Television Installation Agreement dated June, 1996, and recorded in INST # 1997-24424 of the \_\_\_\_\_ Records of Shelby County, Alabama (the "Memorandum"); and

WHEREAS, the Agreement has been amended on even date herewith to shorten the term of the Agreement to July 15, 2003 and to grant certain exclusive rights, pursuant to and in accordance with that certain Amendment to Cable Television Installation Agreement (the "Amendment").

NOW THEREFORE, this Memorandum of Amendment to Cable Television Installation Agreement is being placed of record to notify all persons and parties of the existence of the Agreement and the Amendment and to specifically and expressly notify all persons and parties that the term of the Agreement has been shortened to July 15, 2003. Nothing contained herein will amend, modify, alter or enlarge the Agreement, as amended and modified by the Amendment, and/or any of the terms thereof and in the event of any inconsistency between the Agreement, as modified and amended by the Amendment, and this Memorandum, then the Agreement, as modified and amended by the Amendment, will control.

SPECIAL NOTE: In the Agreement the Grantee was named as Shelby Cable TV INC. The correct name of the Grantee is Shelby Cable Inc. This Addendum recognizes and corrects this item.

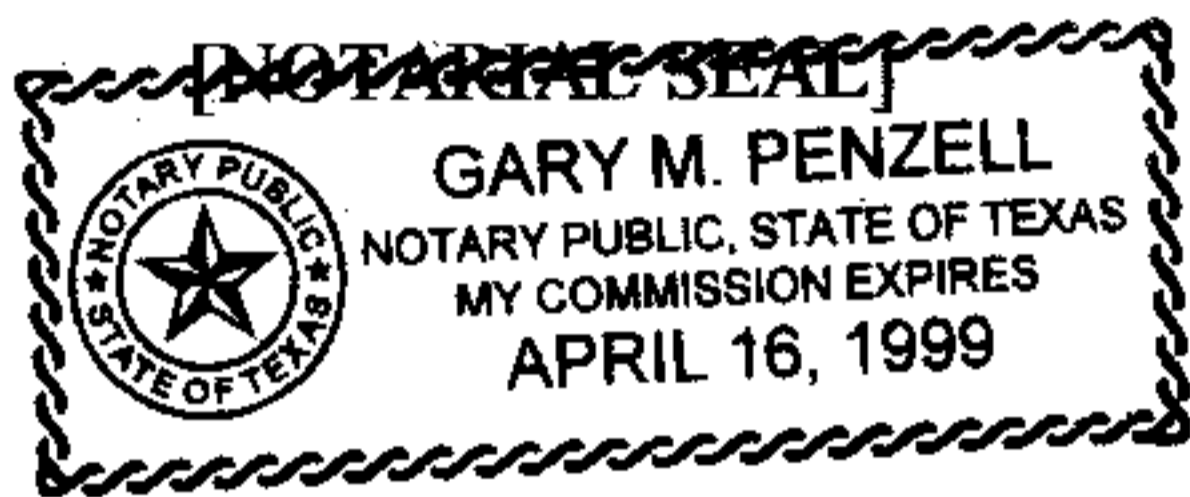
