KNOW ALL MEN BY THESE PRESENTS,

That in consideration of TWO HUNDRED SEVENTEEN THOUSAND FIVE HUNDRED AND NO/100 DOLLARS (\$ 217,500.00) to the undersigned grantor in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **Joe L. Langston, Jr. AND WIFE Melissa O. Langston**, (herein referred to as Grantor) do grant, bargain, sell and convey unto **GENE E. HEAD, JR. AND SHARON L. HEAD** (herein referred to as Grantees) as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of JEFFERSON, to-wit:

Lot 2, according to the Survey of Acton's Addition to Altadena Valley Second Sector, as recorded in Map Book 137, page 43, in the Probate Office of Jefferson County, Alabama.

And we do for ourselves and for our heirs, executors, and administrators covenant with said Grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises, that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and my heirs, executors and administrators shall, warrant and defend the same to the said Grantees, their heirs, and assigns forever, against the lawful claims of all persons.

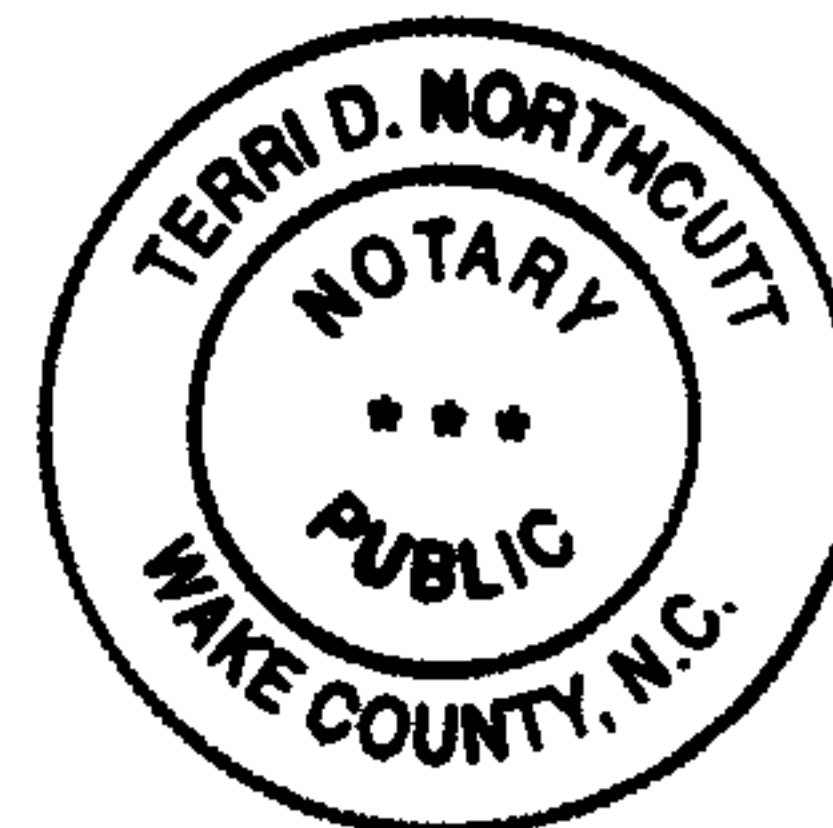
