Part of the W 1/2 of the NW 1/4 of the SE 1/4 of Section 22, Township 21 South, Range 1 East, Shelby County, Alabama, being more particularly described as follows: Beginning at an old rebar being the locally accepted northeast corner of said W 1/2 of NW 1/4 of SE 1/4 of said Section 22, run in a southerly direction along the east line of said W 1/2 of NW 1/4 of SW 1/4 for a distance of 708.0 feet to an existing iron rebar; thence turn an angle to the right of 75 degrees 11 minutes 59 seconds and run in a southwesterly direction for a measured distance of 298.89 feet to an existing old flagged spike being on the east right-of-way line of North Horton Road; thence turn an angle to the right of 81 degrees 11 minutes 25 seconds and run in a Northwesterly direction along the Northeast line of said North Horton Road for a distance of 275.74 feet to an existing iron rebar set by Laurence D. Weygand, and being the point of beginning; thence continue in a northwesterly direction along last mentioned course for a distance of 348.50 feet to an existing iron rebar set by Laurence D. Weygand; thence turn an angle to the right of 90 degrees and run in a northeasterly direction for a distance of 250.0 feet to an existing iron rebar set by Laurence D. Weygand; thence turn an angle to the right of 90 degrees and run in a southeasterly direction for a distance of 348.50 feet to an existing iron rebar set by Laurence D. Weygand; thence turn an angle to the right of 90 degrees and run in a southwesterly direction for a distance of 250.0 feet, more or less, to the point of beginning.
