

Begin at the Northeast corner of the Northwest Quarter of Northeast Quarter of said Section 25; thence in an easterly direction along the north line of said Section 25, a distance of 82 feet to a point in the center of the Little Cahaba River; thence in a southerly direction along said center of the Little Cahaba River a distance of 365 feet; more or less, to a point, said point being 360.82 feet south of, measured perpendicular from, the north line of said Section 25; thence in a Westerly direction along a line parallel to the north line of said Section 25, a distance of 917.41 feet to a point on the northeasterly Right of Way line of an existing County Road; thence 50 degrees 00 minutes 46 seconds right, in a northwesterly direction along said right of way line, a distance of 293.78 feet to the beginning of a curve to the left, having a radius of 680 feet; thence in a northwesterly direction along said curve and right of way line, a distance of 206.38 feet to the intersection with the north line of said Section 25, thence 147 degrees 22 minutes 34 seconds right from tangent to said curve in an easterly direction along the north line of said Section 25, a distance of 1,193.89 feet to the Point of Beginning.
