

# UNIFORM COMMERCIAL CODE - FINANCING STATEMENT - FORM UCC-1

## INSTRUCTIONS

- PLEASE TYPE THIS FORM. FOLD ONLY ALONG PERFORATION FOR MAILING.
- REMOVE SECURED PARTY AND DEBTOR COPIES AND SEND OTHER 3 COPIES WITH INTERLEAVED CARBON PAPER TO THE FILING OFFICER. ENCLOSE FILING FEE (PLUS TAX TO PROBATE JUDGE).
- WHEN FILING IS TO BE WITH MORE THAN ONE OFFICE, REMOVE LAST TWO (2) COPIES OF ANOTHER SET OF FORM 2071 AND PLACE OVER A COMPLETE SET OF FORM 2071.
- IF THE SPACE PROVIDED FOR ANY ITEM(S) ON THE FORM IS INADEQUATE THE ITEM(S) SHOULD BE CONTINUED ON ADDITIONAL SHEETS, PREFERABLY 5" x 8" OR 8" x 10". ONLY ONE COPY OF SUCH ADDITIONAL SHEETS NEED BE PRESENTED TO THE FILING OFFICER WITH A SET OF THREE COPIES OF THE FINANCING STATEMENT. LONG SCHEDULES OF COLLATERAL, INDENTURES, ETC., MAY BE ON ANY SIZE PAPER THAT IS CONVENIENT FOR THE SECURED PARTY.
- IF COLLATERAL IS CROPS OR TIMBER OR GOODS WHICH ARE OR ARE TO BECOME FIXTURES, DESCRIBE GENERALLY THE REAL ESTATE AND GIVE NAME OF RECORD OWNER.
