THIS INDENTURE is made and entered into this 07th day of May, 1996 by and between STANLEY THOMAS COPELAND AND WIFE GIGI MCCORMICK COPELAND (hereinafter called the "Mortgagor," whether one or more) and AmSouth Bank of Alabama, a national banking association (hereinafter called the "Mortgagee").

# Recitals

- "AmSouth Personal Financial Services Line of Credit Agreement" executed by the Borrower in favor of the Mortgagee dated May 07, 1996, as amended by an amendment of even date herewith
- "AmSouth Premium Line of Credit Agreement" executed by the Borrower in favor of the Mortgagee dated May 07, 1996, as amended by an amendment of even date herewith.

The Credit Agreement provides for an open-end line of credit pursuant to which the Borrower may borrow and repay, and repay and repay, amounts from the Mortgagee up to a maximum principal amount at any one time outstanding not exceeding the Credit Limit.

- B. Rate and Payment Changes. The Credit Agreement provides for finance charges to be computed on the unpaid balance outstanding from time to time under the Credit Agreement at an adjustable ANNUAL PERCENTAGE RATE. The annual percentage rate may be increased or decreased on the first day of each billing cycle based on changes in the "Prime Rate" as published in the Wall Street Journal. The ANNUAL PERCENTAGE RATE charged under the Credit Agreement during each billing cycle will be 1.500% above the Prime Rate in effect on the first day of that billing cycle. The annual percentage rate on the date of this mortgage is 9.750%. The annual percentage rate will increase if the Prime rate in effect on the first day of a billing cycle increases, and will decrease if the Prime Rate in effect on the first day of a billing cycle decreases; however, the annual percentage rate will never exceed the Maximum Rate stated in the Credit Agreement. Any increase in the annual percentage rate may result in increased finance charges and increased minimum payment amounts under the Credit Agreement. Any decrease in the annual percentage rate may result in lower finance charges and lower minimum monthly payments.
- C. Maturity Date. If not sooner terminated as set forth therein, the Credit Agreement will terminate twenty years from the day of the Credit Agreement, and all sums payable thereunder (including without limitation principal, interest, expenses and charges) shall become due and payable in full.
