

WARRANTY DEED Joint tenants with right of survivorship

KNOW ALL MEN BY THESE PRESENTS, That in consideration of One Hundred, Twenty Eight Thousand and no/100's Dollars (\$128,000.00) and other good and valuable consideration to the undersigned grantors, WILLIAM TODD MURPHY and wife, DONNA LYNN MURPHY in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged the said WILLIAM TODD MURPHY and wife, DONNA LYNN MURPHY do grant, bargain, sell and convey unto DANIEL B. BARKSDALE and ALECIA B. BARKSDALE as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

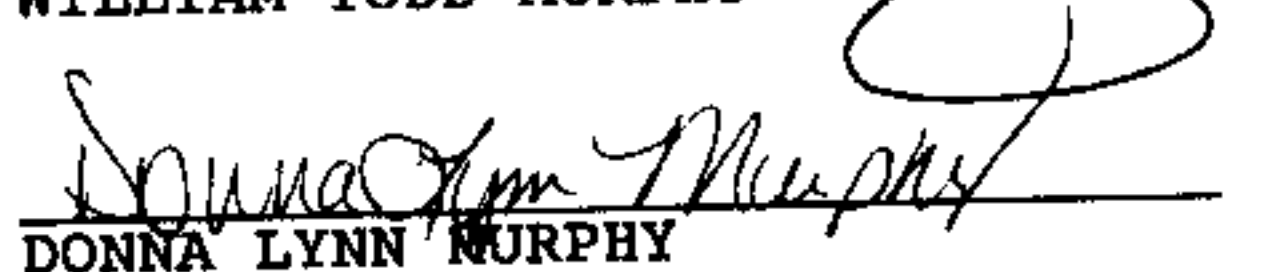

\$121,600.00 of the consideration is paid by a mortgage which is filed simultaneously herewith.

TO HAVE AND TO HOLD, to the said GRANTEEES as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one or more grantees herein survives the other, the entire interest in fee simple shall pass to the surviving grantees, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do, for ourselves and for our heirs, executors and administrators covenant with the said grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises, that they are free of all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to the said grantees, their heirs and assigns forever, against the lawful claims of all persons.

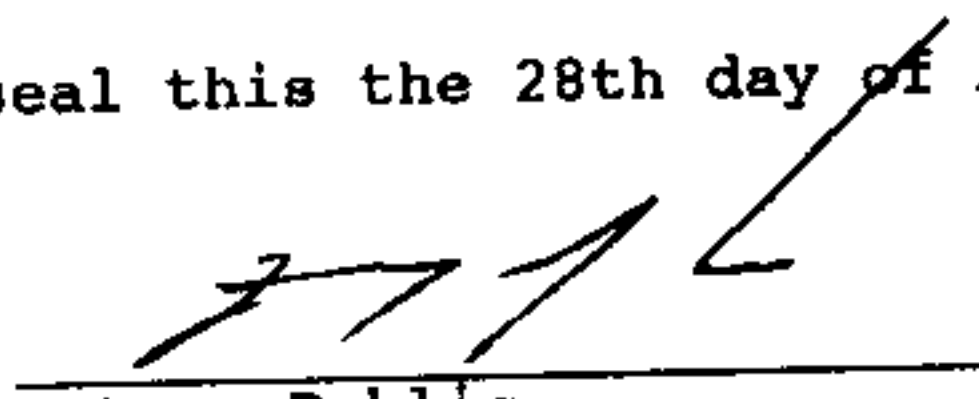
