KNOW ALL MEN BY THESE PRESENTS, that in consideration of FIVE HUNDRED FIFTY THOUSAND AND NO/100 DOLLARS (\$550,000.00) to the undersigned grantor, ELIZABETH RUTH GUNTER, a single person, hereinafter referred to as "Grantor", in hand paid by COALES BRANCH, L.L.C., an Alabama limited liability company, hereinafter referred to as "Grantee", whether one or more, the receipt of which is hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto Grantee the following described real estate, situated in Shelby County, Alabama, together with all improvements and fixtures thereon and all easements and other appurtenances thereto together with all interest of Grantor in any land lying in or under the bed of any street, alley, road, right of way, stream or waterway abutting or immediately adjacent to the real estate and to any strips or gores, if any, between the real estate and abutting or immediately adjacent properties (the "Property"):
