VACATION OF PUBLIC ROAD

We, the undersigned, Warren and Peggy K. Such vacation of said Old Fields Road shall and will not deprive other property owners of such right as they may have to convenient and reasonable means of ingress and egress to and from their property, such right being afforded by the remaining streets and alleys.
