KNOW ALL MEN BY THESE PRESENTS,

That in consideration of THREE HUNDRED NINETY FIVE THOUSAND & NO/100---
(\$395,000.00) DOLLARS to the undersigned grantor or grantors in hand paid by the
GRANTEES herein, the receipt whereof is acknowledged, we, John A. Kemp and wife,
Tanda W. Kemp (herein referred to as grantors), do grant, bargain, sell and convey
unto G. Michael Alder and wife, Marian F. Alder (herein referred to as GRANTEES)
for and during their joint lives and upon the death of either of them, then to the
survivor of them in fee simple, together with every contingent remainder and right
of reversion, the following described real estate, situated in Shelby County,
Alabama, to wit:

Lot 57, according to the Survey of Heatherwood, 4th Sector, 1st Addition, as
recorded in Map Book 11 pages 32 and 33, in the Probate Office of Shelby


TO HAVE AND TO HOLD to the said GRANTEES for and during their joint lives and upon
