### LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that;

**CREDIT SUISSE FIRST BOSTON MORTGAGE CAPITAL LLC** as successor by merger to **CS FIRST BOSTON MORTGAGE CAPITAL CORP.** ("CSFB"), with an address of Eleven Madison Avenue, New York, NY 10010-3629, hereby appoints **Andrew W. Wiederhorn, Lawrence A. Mendelsohn, John McPhee and Michael L. Bell** of **Wilshire Funding Corporation**, with an address of 1776 Southwest Madison, Portland, Oregon 97205, severally, as its true and lawful attorney-in-fact to act in the name, place and stead for the purposes set forth below. This limited power of attorney is given solely with respect to mortgage loans purchased by CSFB pursuant to a certain Loan Sale Agreement by and between CSFB and HUD and assigned to Wilshire Funding Corporation as of the 20th day of May, 1997. The said attorney-in-fact is hereby authorized, and empowered as follows:

1. To execute, acknowledge, seal and deliver the Assignment of Mortgages and Note Allonges without recourse and other collateral loan documents, on behalf of CSFB, with respect to all of the Mortgage Loans, provided that the form of such assignment shall be substantially in the form as set forth in the Loan Sale Agreement by and between CSFB and HUD and assigned to Wilshire Funding Corporation as of the 20th day of May, 1997, modified in accordance with applicable law and appropriately completed.

This instrument is to be construed and interpreted as a limited power of attorney and does not empower or authorize the said attorneys-in-fact to do any act or execute any document on behalf of CSFB not specifically described in the Loan Sale Agreement.

The rights, powers, and authority of the attorneys-in-fact granted in this instrument shall commence and be in full force and effect on the date hereof, and such rights, powers and authority shall remain in full force and effect until 12:00 P.M., December 31, 1997, New York, New York time.
