D/B/A BRENTWOOD MORTGAGE COMPANY (herein referred to as the "Transferor,") for and in consideration of the sum of ONE HUNDRED FIFTY THOUSAND AND 00/100----- (\$ 150,000.00) paid to the Transferor by NEW SOUTH FEDERAL SAVINGS BANK (herein referred to as the "Transferee"), the receipt of which is hereby acknowledged, does hereby transfer, set over, and assign unto the Transferee that certain Promissory Note for ONE HUNDRED FIFTY THOUSAND AND 00/100----- (\$150,000.00) dated OCTOBER 15, 1997, made by PAUL R. BROWNING AND SONYA M. BROWNING being payable to BRENTWOOD PROPERTIES, INC. D/B/A BRENTWOOD MORTGAGE COMPANY or order without recourse., but subject to the terms and conditions of that certain loan purchase agreement dated 1/24/96 between Transferor and Transferee (The "Agreement").
AND, for the same consideration, the Transferor does hereby transfer, set over and assign unto the Transferee that certain mortgage (the "Lien") from PAUL R. BROWNING AND SONYA M. BROWNING to BRENTWOOD PROPERTIES, INC. D/B/A BRENTWOOD MORTGAGE COMPANY, dated OCTOBER 15, 1997, recorded in 1997-33931 10-17-1997 of the records in the Office of the Judge of Probate of SHELBY County, Alabama, which secures the payment of the aforesaid note.

AND, the Transferor does hereby REMISE, RELEASE and QUITCLAIM unto the Transferee all of the right, title and interest of the Transferor in and to the premises and property designated in the Lien, it being the intention of the undersigned to transfer to the Transferee the said debt and the note which evidences the same and said security therefor.

AND, the Transferor represents and warrants to the Transferee that (1) the Lien has not been amended, (II) that there have been no defaults under the lien, (III) that the Transferor has made no prior assignments of the lien, (IV) that the Transferor has good and lawful right to assign the same, (V) that there are no liens superior to the Lien except: ~~(X)~~ None or () _____ from _____ to _____ which the Transferor warrants the unpaid balance on such debt to be no more than \$ _____, (VI) that all disclosures and notices required by the Federal Consumer Credit Protection Act and by the regulations of the Board of Governors promulgated pursuant thereto have been properly made and given in regard to the Lien and, (VII) that all other laws, rules and regulations applicable to the Lien as well as the terms of the Agreement on the part of the Transferor to have performed, have been fully and faithfully complied with.

The Transferor hereby warrants the unpaid balance of said note to be not less than \$ 150,000.00.
