KNOW ALL MEN BY THESE PRESENTS,

That in consideration of EIGHTY ONE THOUSAND NINE HUNDRED & NO/100---
(\$81,900.00) DOLLARS to the undersigned grantor, Jackie Williams Company, Inc. a
