THIS INDENTURE is made and entered into this 9th day of October, 1997 by and between COURTNEY H. MASON JR AND WIFE, CAROLYN B. MASON (hereinafter called the "Mortgagor," whether one or more) and Amsouth Bank, a national banking association (hereinafter called the "Mortgagee").

#### Recitals

- A. The Secured Line of Credit. Courtney H. Mason JRand Carolyn B. Mason (hereinafter call the "Borrower," whether one or more) is/are now or may become in the future justly indebted to the Mortgagee in the maximum principal amount of ONE HUNDRED EIGHTEEN THOUSAND AND 00/100 Pollars (\$118000.00) (the "Credit Limit") pursuant to a certain open-end line of credit established by the Mortgagee for the borrower under an The second secon agreement (the "Credit Agreement"), entitled "AmSouth Equity Line of Credit Agreement" executed by the Borrower in favor of the Mortgagee, dated October 09 1997 "AmSouth Personal Financial Services Line of Credit Agreement" executed by the Borrower in favor of the Mortgagee dated October 09, 1997, as amended by an amendment of even date herewith "AmSouth Premium Line of Credit Agreement" executed by the Borrower in favor of the Mortgagee dated October 09, 1997, as amended by an amendment of even date herewith. The Credit Agreement provides for an open-end line of credit pursuant to which the Borrower may borrow and repay, amounts from the Mortgagee up to a maximum principal amount at any one time outstanding not exceeding the Credit Limit.
- B. Rate and Payment Changes. The Credit Agreement provides for finance charges to be computed on the unpaid balance outstanding from time to time under the Credit Agreement at an adjustable ANNUAL PERCENTAGE RATE. The annual percentage rate may be increased or decreased on the first day of each billing cycle based on changes in the "Prime Rate" as published in the Wall Street Journal. The ANNUAL PERCENTAGE RATE charged under the Credit Agreement during each billing cycle will be 1.500% above the Prime Rate in effect on the first day of that billing cycle. The annual percentage rate on the date of this mortgage is 10.000%. The annual percentage rate will increase if the Prime rate in effect on the first day of a billing cycle increases, and will decrease if the Prime Rate in effect on the first day of a billing cycle decreases; however, the annual percentage rate will never exceed the Maximum Rate stated in the Credit Agreement. Any increase in the annual percentage rate may result in increased finance charges and increased minimum payment amounts under the Credit Agreement. Any decrease in the annual percentage rate may result in lower finance charges and lower minimum monthly payments.
- C. Maturity Date. If not sooner terminated as set forth therein, the Credit Agreement will terminate twenty years from the day of the Credit Agreement, and all sums payable thereunder (including without limitation principal, interest, expenses and charges) shall become due and payable in full.
- D. Mortgage Tax. This mortgage secures open-end or revolving indebtedness with an interest in residential property. therefore, under §40-22-2(1)b, Code of Alabama 1975, as amended, the mortgage filing privilege tax shall not exceed \$0.15 for each \$100, or fraction thereof, of the Credit Limit of \$118000.00, which is the maximum principal indebtedness, to be secured by this mortgage at any one time. Although the interest rate payable on the line of credit may increase if the Prime Rate in effect on the first day of a billing cycle increases, the increased finance charges that may result are payable monthly under the Credit Agreement and there is no provision for negative amortization, capitalization of unpaid finance charges or other increases in the principal amount secured hereby over and above the Credit Limit. therefore, the principal amount secured will never exceed the Credit Limit unless an appropriate amendment hereto is duly recorded and any additional mortgage tax due on the increased principal amount paid at the time of such recording.

#### Agreement
