KNOW ALL MEN BY THESE PRESENTS, That in consideration of **FOUR HUNDRED TWENTY-SEVEN THOUSAND DOLLARS AND NO/100's (\$427,000.00)** to the undersigned grantor, **VISTA HOMES, INC.**, a corporation, (herein referred to as **GRANTOR**), in hand paid by the **GRANTEES** herein, the receipt of whereof is acknowledged, the said **GRANTOR** does by these presents grant, bargain, sell, and convey unto **BRUCE A. EFIRD and GAYLA P. EFIRD** (herein referred to as **GRANTEES**) as joint tenants, with right of survivorship, the following described real estate, situated in **SHELBY County, Alabama**:

Lot 223, according to the Survey of Highland Lakes, 2nd Sector, an Eddleman Community, as recorded in Map Book 20, Page 150, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.
