# Regions Bank CONSTRUCTION MORTGAGE

THIS MORTGAGE IS DATED OCTOBER 10, 1997, between Billy J. Lee and Catherine H. Lee, man and wife, whose address is 306 Chase Lake Parkway, Birmingham, AL 35244 (referred to below as "Grantor"); and Regions Bank, whose address is 2964 Highway 31 South, Pelham, AL 35124 (referred to below as "Lender").

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, grants, bargains, sells and conveys to Lender all of Grantor's right, title, and interest in and to the following described real property, together with all existing or subsequently erected or affixed buildings, improvements and fixtures; all easements, rights of way, and appurtenances; all water, water rights, watercourses and ditch rights (including stock in utilities with ditch or irrigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar matters, located in Shelby County, State of Alabams (the "Real Property"):

Lot 25, according to a Re-Survey of Lots 23 and 25 of High Hampton, Sector 3, as recorded in Map Book 23, Page 26 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

The Real Property or its address is commonly known as Lot 25, Hampton Cove, Pelham, AL 35124. The Real Property tax identification number is 58-14-4-18-1-000-001.

Grantor presently assigns to Lender all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property In addition, Grantor grants to Lender a Uniform Commercial Code security interest in the Personal Property and Rents.

DEFINITIONS. The following words shall have the following meanings when used in this Mortgage. Terms not otherwise defined in this Mortgage shall have the meanings attributed to such terms in the Uniform Commercial Code. All references to dollar amounts shall mean amounts in lawful money of the United States of America.

Indebtedness. The word "Indebtedness" means all principal and interest payable under the Note and any amounts expended or advanced by Lender to discharge obligations of Grantor or expenses incurred by Lender to enforce obligations of Grantor under this Mortgage together with interest on such amounts as provided in this Mortgage.

Lender. The word "Lender" means Regions Bank, its successors and assigns. The Lender is the mortgages under this Mortgage.

Note. THIS MORTGAGE IS GIVEN AND ACCEPTED ON THE FOLLOWING TERMS:
