KNOW ALL MEN BY THESE PRESENTS, That in consideration of TWO HUNDRED SEVENTY-NINE THOUSAND FIVE HUNDRED DOLLARS AND NO/100's (\$279,500.00) to the undersigned grantor, DENMAN CONSTRUCTION COMPANY, INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto JAMES C. MCWILLIAMS and LINDA T. MCWILLIAMS (herein referred to as GRANTEEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:

Lot 746, according to the Survey of Highland Lakes, 7th Sector, an Eddleman Community, as recorded in Map Book 20, Page 58 A, B and C, in the Probate Office of Shelby County, Alabama.
