2. That Clara Jean Blair Rasco, is a resident citizen of Shelby County, Alabama and is over the age of nineteen (19) years of age.
3. That Mitchell D. Blair, is a resident citizen of the State of Arkansas, and is over the age of nineteen (19) years of age.
4. That John Paul Blair, is a resident citizen of the State of Texas, and is over the age of nineteen (19) years of age.
5. That Lee K. Blair, is a resident citizen of the State of Utah, and is over the age of nineteen (19) years of age.
