## TWELFTH AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR MEADOW BROOK CORPORATE PARK SOUTH

THIS TWELFTH AMENDMENT TO DECLARATION is made as of the <u>20th</u> day of November, 1997 by DANIEL U.S. PROPERTIES LIMITED PARTNERSHIP II, an Alabama limited partnership (the "Developer").

Capitalized terms not otherwise defined herein shall have the same meanings given to them in the Declaration.

Pursuant to Sections 3.02 and 4.13 of the Declaration, Developer desires to amend the Declaration to revise and restate Exhibits A and B to the Declaration to reflect (i) the resubdivision of former Lot 9-B-3, according to the Resurvey of Lot 9-B, Meadow Brook Corporate Park South, Phase II, as recorded in Map Book 19, Page 88 in the Probate Office, into two (2) Lots and (ii) to reflect the name change of Lot 9-B-2B-2, being a Resurvey of Lot 9-B-2, Meadow Brook Corporate Park South, Phase II as recorded in Map Book 23, Page 91 in the Probate Office.
