KNOW ALL MEN BY THESE PRESENTS, That in consideration of FOUR HUNDRED SIXTY-SIX THOUSAND DOLLARS AND NO/100'S DOLLARS (\$466,000.00) to the undersigned grantor, PRECISION HOMEBUILDERS, INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto C.S. DANGLER, JR. and MARGARET B. DANGLER (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:

Lot 2127, according to the Survey of Brook Highland, an Eddleman Community, 21st Sector, as recorded in Map Book 18, Page 52 A & B, in the Probate Office of Shelby County, Alabama.

Subject to:

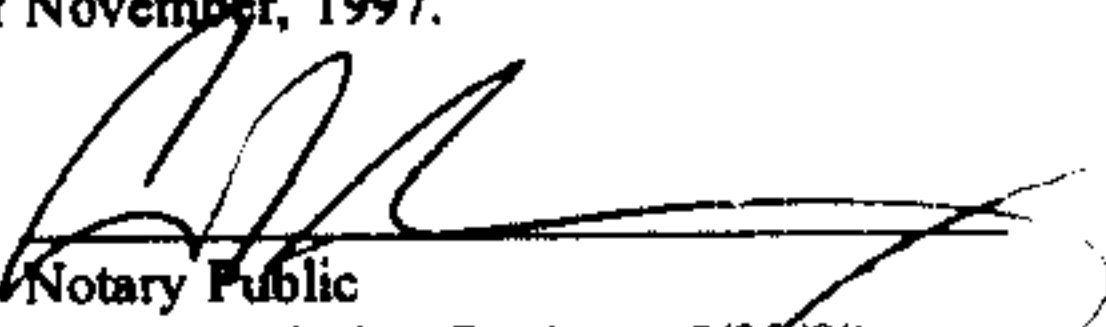
