2. The following amendment was adopted in the manner provided for by the Alabama Business Corporation Act:

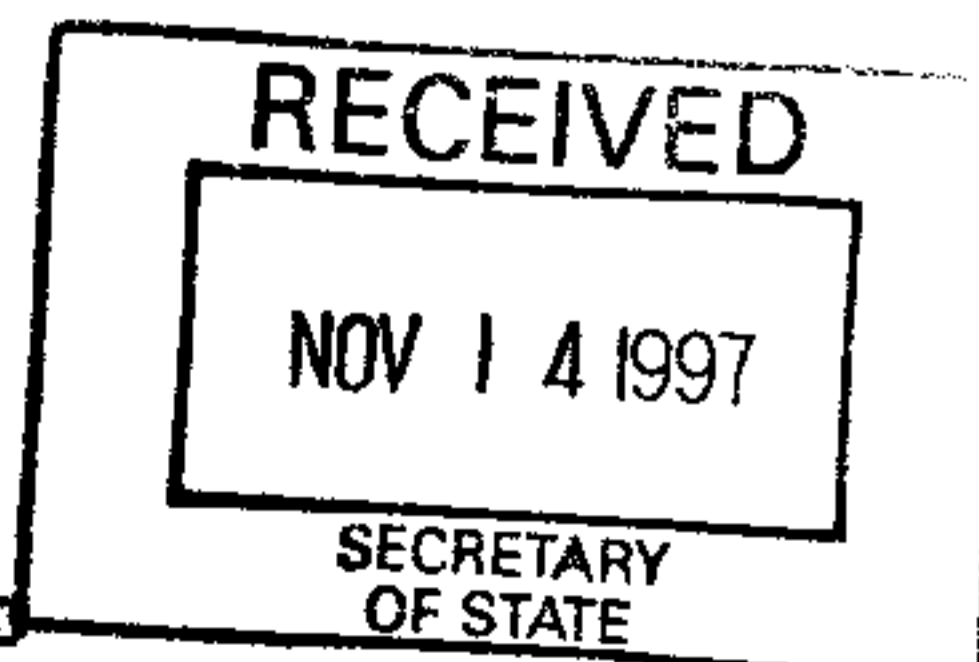
Articles I, II and IV are hereby amended in order to reflect the correct spelling of the corporation and the Registered Agent:
