CORPORATION WARRANTY DEED
JOINT WITH RIGHT OF
SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS, That in consideration of other good and valuable considerations and the sum of ONE HUNDRED FORTY SEVEN THOUSAND ONE HUNDRED TWENTY SIX DOLLARS AND 00 CENTS (US\$147,126.00) Dollars to the undersigned GRANTOR in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, Doyal Construction Co., Inc., a Corporation (hereinafter referred to as GRANTOR), does hereby grant, bargain, sell and convey unto James E. Broadwater and wife, Jo D. Broadwater, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in the County of Shelby and State of Alabama, to-wit:
