## COVENANTS TO RUN WITH LAND

NOW, THEREFORE, in consideration of the premises, the owners, <u>OALE H. YOUNG TENETTE & ALAN</u>, hereby grants and convey as encumbrances on land described as Exhibit "A" the following restrictions and covenants to run with the land as hereinafter described:

1. That the undersigned owners, DALE # YOUNG + LOLA JEANETE CAIN YOUNG its successors, assigns and subsequent purchasers of a commercial \_,Shelby County shall own the said building subject to the continuing condition that building at CHELSEA the right to use the said building and right to continue to occupy the said building will be subject to the proper functioning of the alternative sewage disposal system which is being approved by the Shelby County Board of Health through its Health Officer. In the event it is determined by the Shelby County Health Department that the alternative sewage disposal system is no longer functioning properly and that the continued occupancy of their building is detrimental to their health or the health of other occupants or residences in the general arda, then the owner or occupant agrees upon written notice from the said Health Officer to vacate said building as directed in said notice.

- 2. The owners and his successors in title will install and maintain for the disposal of sewage and alternative sewage disposal system approved under the provisions of Alabama's Onsite Sewage Rules Chapter 420-3-1, Alabama Administrative Code.
- 3. The owners and their successors in title shall install and maintain low water use type flush toilets, shower heads and other water saving fixtures, where applicable, whether new or replacement fixtures as determined to be acceptable by the Shelby County Health Officer.

- 4. That the whole of the land in Exhibit "A" shall not be subdivided until a public or private sanitary sewer system is available.
- 5. No repair, alteration or addition shall be made to the approved alternative sewage disposal system without the written approval of the Shelby County Health Officer.
- 6. That these covenants shall run with the land and be binding on all present owners and future owners or occupants of said building and the lot on which it is situated until such time as the alternative sewage disposal system is no longer required by the Shelby County Board of Health, the same being the occasion when the business is connected to a public or private sanitary sewer system.
