(D) Limits on Interest Rate Changes

The existing interest rate will never increase or decrease by more than ONE 1.000%) on any single Change percentage point(s) ( percentage point(s) Date. The interest rate will never be more than FIVE 5.000% ) higher or lower than the initial interest rate, as stated in Paragraph 2 of the Note

(E) Calculation of Payment Change

If the interest rate changes on a Change Date, Lender will calculate the amount of monthly payment of principal and interest which would be necessary to repay the unpaid principal balance in full at the Maturity Date at the new interest rate through substantially equal payments.
