Lot 6, according to the survey of Navajo Estates, as recorded in Map Book 21, Page 140, in the Probate Office of Shelby County, Alabama.

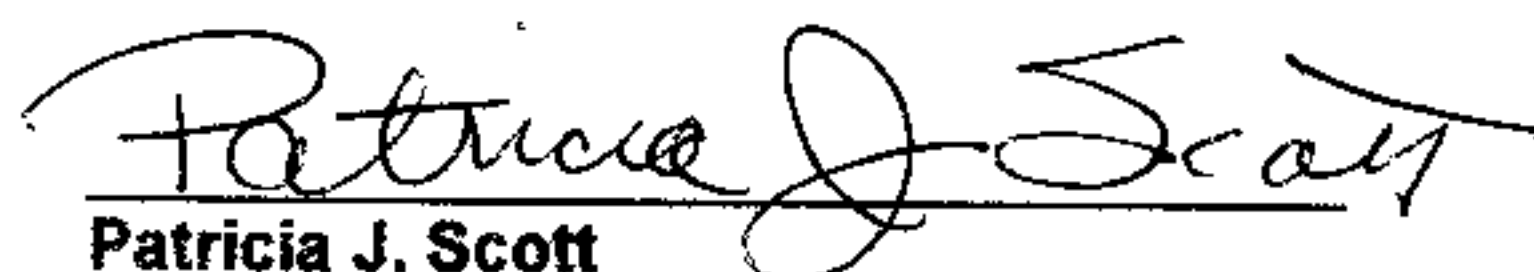
