KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of Elghty Thousan	id. Seven

Dollars (\$ 80,750,00 ), in hand paid by Grantee to Grantor and other good and valuable consider	
and sufficiency of which are hereby acknowledged by Grantor, Grantor does by these presents, GRANT, BAR	GAIN SELL and
CONVEY unto Grantee the following described real property (the "Property") offusted in Shelby County, Alaba	ma:

Lot 5, according to the Survey of Greystone, 7th Sector, Phase V. as recorded in Map Book 23 page 61 in the Probate Office of Shelby County.

The Property is conveyed subject to the following:

- 1. Ad valorem taxes due and payable October 1, \_\_1998\_\_\_, and all subsequent years thereafter.
- 2. Fire district dues and library district assessments for the current year and all subsequent years thereafter.
- Mining and mineral rights not owned by Grantor.
- 4. All applicable zoning ordinances.
- 5. The easements, restrictions, reservations, covenants, agreements and all other terms and provisions of the Greystand Residential Declaration of Covenants, Conditions, and Restrictions dated November 6, 1990 and recorded in Real 317, Page 260 in the Probate Office of Shelby County, Alabama, as amended, (which, together with all amendments thereto, is hereinafter collectively referred to as the Declaration").
- 6. Any Dwelling built on the Property shall contain not less than \_\_\_\_\_ 2,600 \_\_\_\_\_ square feet of Living Space, as defined in the Declaration, for a single-story house; or \_\_\_\_\_ 3,000 \_\_\_\_\_ square feet of Living Space, as defined in the Declaration, for multi-story home.
- 7. Subject to the provisions of Sections 6.04(c), 6.04(d) and 6.05 of the Declaration, the Property shall be subject to the following minimum setbacks:
  - (i) Front Setback: 35 feet;
  - (ii) Rear Setback: 35 feet;
  - (iii) Side Serbacks: 10 feet.

The foregoing setbacks shall be measured from the property lines of the Property

8. All easements, restrictions, reservations, agreements, rights-of-way, building sethack lines and any other matters of record Grantee, by acceptance of this deed, acknowledges, covenants and agrees for itself and its successors and assigns, that,

(i) Grantor shall not be liable for and Grantee hereby waives and releases Grantor its officers, agents, employees, directors, shareholders, partners, mortgagees and their respective successors and assigns from any liability of any nature on account of loss, damage or injuries to buildings, structures, improvements, personal property or to Grantee or any owner, occupants or other person who enters upon any portion of the Property as a result of any past, present or future soil, surface and/or subsurface conditions, known or unknown (including, without limitation, sinkholes, underground mines, tunnels and lime stone formations and deposits) under or upon the Property or any property surrounding, adjacent to or in dose proximity with the Property which may be owned by Grantor;

- (ii) Grantor, its successors and assigns, shall have the right to develop and construct attached and detached townhouses, condominiums, cooperatives, duplexes, zero-lot-line homes and cluster or patio homes on any of the areas indicated as "MI)" or medium density residential land use classifications on the Development Plan for the Development; and
- (iii) The purchase and ownership of the Property shall not entitle Grantee or the family members, guests, invitees, heirs, successors or assigns of Grantee, to any rights to use or otherwise enter onto the golf course, clubhouse and other related facilities or amenities to be constructed on the Golf Club Property, as defined in the Declaration.
