The Lander has the authority to settle any claim for insurance benefits and to collect the proceeds. ### 5. FUNDS FOR TAXES AND INSURA

Under paragraphs 3 and 4 of this Mortgage, I am required to pay all texes, assessments and hazard insurance premiums and upon request of Lender furnish receipts for such payments. As an alternative to the payment of such amounts directly by me, if required by Lender, I agree to pay to Lender on the day monthly payments are due under the Note, until the Note is paid in full, a sum ("Funds") for : (a) yearly taxes and assessments which may attain priority over this Mortgage as a lien on the Property, (b) yearly leasehold payments or ground rents on the Property, if any; (c) yearly hazard or property insurance premiums; (d) yearly flood insurance premiums, if any; and (e) yearly mortgage insurance premiums, if any. These items are defied "Escrow Items." Lender may, at any time, collect and hold Funds in an amount not to exceed the maximum amount a lander for a federally related mortgage loan may require for Borrower's secrow account under the Federal Real Estate Sattlement Procedures Act of 1974 as amended from time to time, 12 U.S.C. § 2601 ar seq. ("RESPA"), unless another law that applies to the Funds sets a lesser amount. Lender shall use the Funds to pay the Escrow items. Lender may not charge me for holding and applying the Funds, annually enalyzing the escrow account, or verifying the Escrow Items, unless Lender pays me interest on the Funds and applicable law permits Lender to make such a charge. If: (A) I do not keep my promises and agreements made in this Mortgage, or (B) someone, including me, begins a legal proceeding that may significantly effect Lender's rights in the Property (such as, a legal proceeding in bankruptcy, in probate, for condemnation, or to enforce laws and regulations), then Lender may do and pay for whatever is necessary to protect the Property and Lender's rights in the Property.
