Mortgager shall furnish Mortgages certificates of insurance issued by insurance companies satisfactory to Mortgages showing that the amount and type of insurance required by Mortgages hereunder is in effect. All renewal policies, with premiums paid, shall be delivered to Mortgagee at least thirty (30) days before the expiration of the old policies. If any insurance, or any part thereof, shall expire,

or be withdrawn or become void or unsafe by Mortgagor's breach of any condition thereof, or become void or unsafe by reason of the failure or impairment of the capital of any company by which the insurance may then be carried, or if for any reason whatever the insurance shall be unsatisfactory to Mortgagee, Mortgagor shall produce and deliver to Mortgagee new insurance on the premises, satisfactory to Mortgagoe. If Mortgagor fails to produce and deliver such new insurance, Mortgagoe may, but shall not be obligated to, produce same, and upon demand, Mortgagor shall give immediate notice in writing to Mortgagoe of any loss, injury or damage affecting the mortgagod real estate caused by any casualty or occurrence. Full power is hereby conferred on Mortgagoe to sattle and compromise claims under all policies and to demand, receive, and receipt for all mortes becoming payable thereunder and to assign absolutely all policies to any holder of the note or to the grantee of the real estate in the event of the foreclosure of this mortgagee and security agreement or other transfer of title to the real estate in extinguishment of the indebtedness(as) secured hereby. In the event of any breach of this covenant the Mortgagee may, in addition to any other rights or remedies, at any time thereafter, declars the whole of the indebtedness(es) secured hereby immediately due and payable.
- 5. That Mortgagor agrees that the indebtedness(es) hereby secured shall at once become due and payable and this mortgage subject to foreclosure as provided for herein, at the option of holder hereof, when and if any statement of lien is filed under the statutes of Alabama relating to the fiens of mechanics and materialmen, without regard to form and contents of such statement, and without regard to the existence or nonexistence of the debt, or any part thereof, or of the lien, on which such statement is based.
- 6. That Mortgagor shall comply with all statutes, ordinances, regulations and laws promulgated by any governmental entity asserting jurisdiction over the real estate and any and all legal requirements shall be fully complied with by Mortgagor.
