WARRANTY DEED, JOINTLY FOR

KNOW ALL MEN BY THESE PRESENTS, That in consideration of other good and valuable considerations and the sum of TWO HUNDRED FIFTEEN THOUSAND DOLLARS AND 00 CENTS (US\$215,000.00) to the undersigned GRANTORS in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, Daniel A. Novotny by Maureen K. Novotny his Attorney-in-Fact, and wife, Maureen K. Novotny, (hereinafter referred to as GRANTORS), do hereby grant, bargain, sell and convey unto Lawrence A. Edgar and wife, Ruth V. Edgar and Todd Anthony Edgar, a single man, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in the County of Shelby and State of Alabama, to-wit:

Lot 61-A, according to the Resurvey of Lots 57-64, The Fairways at Riverchase, as recorded in Map Book 19, Page 43, in the Probate Office of Shelby County, Alabama.
