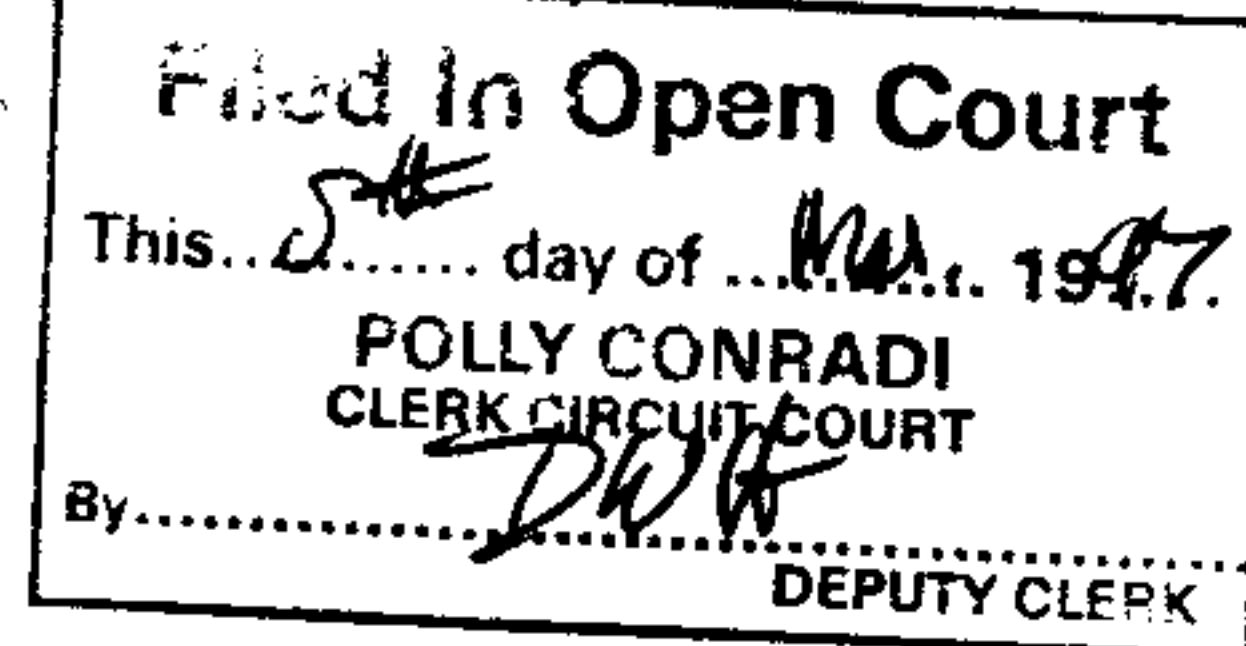


**JUDGMENT**

This cause came on to be heard as a motion for summary judgment, and by agreement of the defendants, it is due to be granted by the entry of judgment against Maxx Petroleum/Marts, Inc., Don J. Vincent, individually, and V. J. Corporation, Inc., and upon due consideration, it is ORDERED, ADJUDGED and DECREED by the Court as follows:

1. Judgment is hereby rendered in favor of plaintiff, Koch Industries, Inc., and against defendants Maxx Petroleum Marts, Inc., Don J. Vincent, individually, and V. J. Corporation, Inc., in the principle amount of Sixty Seven Thousand Five Hundred Eleven and 84/100 Dollars (\$67,511.84) plus pre-judgment interest of six (6) percent per annum in the amount of \$3,828.09 for a total sum of \$71,339.93, attorneys fees in the sum of \$4,731.00, plus interest at the rate of twelve (12) percent per annum for post judgment interest, until paid.

2. Costs of this action are taxed to the defendants, Maxx Petroleum/Marts, Inc., Don J. Vincent and V. J. Corporation, Inc.
