PARTIAL ASSIGNMENT OF RIGHTS

THIS PARTIAL ASSIGNMENT OF RIGHTS (this "Assignment") is made and entered into as of the 24 day of November, 1997 by DANIEL OAK MOUNTAIN LIMITED PARTNERSHIP, an Alabama limited partnership ("Daniel"), in favor of GREYSTONE VILLAGE OWNER'S ASSOCIATION, INC., an Alabama nonprofit corporation (the "Association").

RECITALS:

Daniel and School House Properties, an Alabama general partnership now known as Taylor Properties, L.L.C., an Alabama limited liability company ("Developer"), have heretofore entered into the Amended and Restated Greystone Village Declaration of Covenants, Conditions and Restrictions dated as of February 21, 1994 (the "Original Declaration") which has been recorded as Instrument No. 1994-12222 in the Office of the Judge of Probate of Shelby County, Alabama. Capitalized terms not otherwise expressly defined herein shall have the same meanings given to them in the Declaration.

Pursuant to <u>Section 5.01</u> of the Declaration, Daniel retained the sole and exclusive right to approve all Improvements of any nature which may be constructed on any Lot or Dwelling within the Property. Furthermore, pursuant to the terms and provisions of <u>Section 5.10</u> of the Declaration, Daniel reserved the right to assign any and all of its rights, powers, reservations and duties contained in <u>Article V</u> of the Declaration to the Association or to any other person or entity.

Daniel desires to transfer and assign to Association all of the rights, duties, and responsibilities of Daniel pursuant to Article V of the Declaration

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- 1. <u>Assignment of Rights</u>. Daniel does hereby transfer, assign, set-over and deliver to Association all of the rights, powers, duties and authority of Daniel in <u>Article V</u> of the Declaration (the "<u>Assigned Rights</u>"). From and after the date hereof, all of the Assigned Rights shall be exercised by the Association and Daniel shall have no further rights or obligations under <u>Article V</u> of the Declaration.
- 2. <u>Assumption of Obligations</u>. The Association, by execution hereof, does hereby accept and assume all of the Assigned Rights.
