All renewal policies, with premiums paid, shall be delivered to Mortgaged at least thirty (30) days before the expiration of the old policies. If any insurance, or any part thereof, shall expire,

If Mortgagor shall reimburse mortgagee all such costs expended with interest on such advance at the rate set forth in the note secured hereby.
