Recitals

(\$ 2:	A. The Secured Line of Credit. Stephen C. Richardson and Mary E. Richardson (hereinafter call the "Borrower," whether one or more) is/are or may become in the future justly indebted to the Mortgagée in the maximum principal amount of TWENTY-FIVE THOUSAND & 00/100 Dollars (50,00.00) (the "Credit Limit") pursuant to a certain open-end line of credit established by the Mortgagee for the borrower under an agreement (the pait Agreement"), entitled
t/	"AmSouth Equity Line of Credit Agreement" executed by the Borrower in favor of the Mortgagee, dated January 16 1998
	"AmSouth Personal Financial Services Line of Credit Agreement" executed by the Borrower in favor of the Mortgagee dated January 16, 1998, as amended by an amendment of even date herewith
	"AmSouth Premium Line of Credit Agreement" executed by the Borrower in favor of the Mortgagee dated January 16, 1998, as amended by an amendment of even date herewith.

The Credit Agreement provides for an open-end line of credit pursuant to which the Borrower may borrow and repay, amounts from the Mortgagee up to a maximum principal amount at any one time outstanding not exceeding the Credit Limit.

- B. Rate and Payment Changes. The Credit Agreement provides for finance charges to be computed on the unpaid balance outstanding from time to time under the Credit Agreement at an adjustable ANNUAL PERCENTAGE RATE. The annual percentage rate may be increased or decreased on the first day of each billing cycle based on changes in the "Prime Rate" as published in the Wall Street Journal. The ANNUAL PERCENTAGE RATE charged under the Credit Agreement during each billing cycle will be 1.500% above the Prime Rate in effect on the first day of that billing cycle. The annual percentage rate on the date of this mortgage is 10.000%. The annual percentage rate will increase if the Prime rate in effect on the first day of a billing cycle increases, and will decrease if the Prime Rate in effect on the first day of a billing cycle decreases; however, the annual percentage rate will never exceed the Maximum Rate stated in the Credit Agreement.
