That in consideration of EIGHTY ONE THOUSAND ONE HUNDRED & NO/100---- (\$81,100.00) DOLLARS to the undersigned grantor, Jackie Williams Company, Inc. a corporation, (herein referred to as the GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto Michael S.
