Existing covenants and restrictions, easements, building lines and limitations of record.

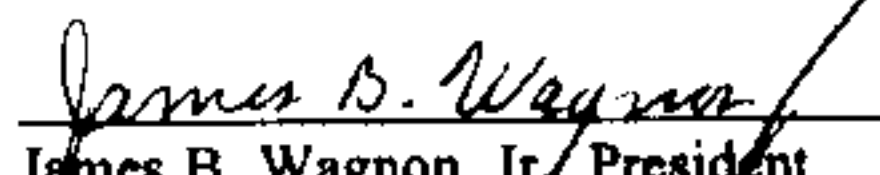
\$ 110,000.00 of the purchase price recited above was paid from a mortgage loan closed simultaneously herewith.
