County, Alabama and described as follows:		

Commence at the centerline intersection of Alabama Highway 119 and Southgate Drive as shown on the record map of Southgate Industrial Park Right-of-Way Dedication Plat as recorded in Map Book 20 at Page 98 in the Office of the Judge of Probate, Shelby County, Alabama; thence run in a Northwesterly direction along the centerline of Southgate Drive (having a right-of-way 60 feet in width) a distance of 373.77 feet to a point; thence turn a deflection angle to the left of 105°57'44" and run in a Southwesterly direction a distance of 31.20 feet to a point on the Southwesterly right-of-way of said Southgate Drive, said point also being the POINT OF BEGINNING of the centerline of a 20-foot easement, 10 feet either side of said centerline, for sanitary sewer; thence continue on the last described course in a Southwesterly direction a distance of 38.37 feet to a point; thence turn a deflection angle to the right of 14°03'56" and run in a Southwesterly direction a distance of 368.86 feet to a point, said point being the ENDPOINT of said centerline and said easement.

The undersigned covenant with said Grantee that the undersigned are seized in fee-sumple of said premises and have a good right to sell and convey the same and that the same free from all encumbrances, and the undersigned will warrant and defend the title to the aforegranted strip of ground from and against the lawful claims of all persons whomsoever
