

RESOLUTION NO. 1886-98

WHEREAS, Daniel Oak Mountain Limited Partnership, Wiggins Construction, and Frederick Sommer are the owners of all the property abutting or adjacent to the following described easement proposed to be vacated, situated in Shelby County, Alabama, to-wit:

An easement to be vacated being a part of Lot 11B of A Resurvey of Lot 11A of A Resurvey of Lots 11 and 12 Greystone 5<sup>th</sup> Sector Phase II as recorded in Map Book 21, on Page 152, in the Office of the Judge of Probate, Shelby County, Alabama, being more particularly described as follows

Commence at the Southwest corner of said Lot 11B, said corner also being the Southeast corner of Lot 12A in A Resurvey of Lots 11 and 12 Greystone 5<sup>th</sup> Sector Phase II as recorded in Map Book 20, on Page 92, in the Office of the Judge of Probate, Shelby County, Alabama; thence run in a northeasterly direction along the Northwest line of said Lot 11B and also along the Southeast line of said Lot 12A for a distance of 156.73 feet to a point; thence turn an angle to the right of 99°22'02" and run in a southeasterly direction for a distance of 7.60 feet to the point of beginning, thence continue along last stated course for a distance of 200.27 feet to a point; thence turn an angle to the left of 130°57'15" and run in a northeasterly direction for a distance of 61.65 feet to a point; thence turn an angle to the left of 56°03'24" and run in a northwesterly direction for a distance of 165.45 feet to a point; thence turn an angle to the left of 92°21'23" and run in a southwesterly direction for a distance of 26.72 feet to the point of beginning.

WHEREAS, the above owners are desirous of vacating a portion of said easement described above and requests that the assent of the Council of the City of Hoover, Alabama, be given as required by law in such cases;

After vacation of the above described easement, convenient means of ingress and egress to and from the property will be afforded to all other property owners owning property in or near the tract of land embraced in said map, plat or survey.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hoover, Alabama, that it does hereby assent to the vacation of the said easement as above described and that the same is hereby vacated and annulled and all public rights and easements therein are hereby divested.
