KNOW ALL MEN BY THESE PRESENTS,

That in consideration of ONE HUNDRED SIXTY SEVEN THOUSAND FIVE HUNDRED AND NO/100 DOLLARS (\$167,500.00), to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **BEN F. ROBINSON, JR. AND WIFE BARBARA M. ROBINSON**, (herein referred to as Grantors) do grant, bargain, sell and convey unto **MARK WALDEN, JR. AND NATALIE R. WALDEN** (herein referred to as Grantees), as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of SHELBY, to-wit:
