The undersigned, acting as incorporator of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for such corporation.

FIRST: The name of the Corporation is THE MASTER'S TOUCH LANDSCAPE SERVICES, INC.

SECOND: The period of its duration is perpetual.

THIRD: The authorized corporate purposes shall be to engage in the landscape and design of residential and commercial properties and to conduct any and all lawful business purpose or purposes which a corporation organized under Title 10 of the Code of Alabama may be permitted to undertake.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1000) shares, all common, of a par value of One Dollar (\$1.00) each.




