

SPECIFIC DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That I, Kenneth L. Booth

constituted and appointed, by these presents do make, constitute
and appoint Karen C. Booth, my true and lawful Attorney-in-Fact

1. SPECIFIC GRANT OF POWER: To exercise or perform
the specific act enumerated below relating to the transaction of

me. I grant my Agent full power and authority to do fully as I
might or could do if personally present, with full power of
substitution or revocation, hereby ratifying and confirming all
that my Agent shall lawfully do or cause to be done by virtue of
