

**ARTICLES OF ORGANIZATION
OF
GOLDEN TRIANGLE, LLC**

Pursuant to the Provisions of Act No. 97-920 of the 1997 Alabama Legislature, the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I

NAME

GOLDEN TRIANGLE, LLC

ARTICLE II

DURATION

The term shall expire on December 31, 2048, unless the Company shall be sooner dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act or the Operating Agreement.

ARTICLE III

PURPOSES

The Limited Liability Company has been organized for the following purposes:

To operate, conduct and maintain a business engaged in the acquisition, development, management and brokerage of real estate and to engage in any lawful business permitted under Alabama law as may be agreed upon by the Members.

ARTICLE IV

The Company shall be Member-managed.


ARTICLE VII
