

**ARTICLES OF INCORPORATION  
OF

TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY,  
ALABAMA:

The undersigned, Warren E. Behling, acting as incorporator of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for the corporation:

1. The name of the corporation shall be **Behling Consulting, Inc.**, and the corporation shall be authorized to operate under that name or use any other trade name not now being used by another person, firm or corporation.
2. The purpose for which the corporation is formed is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Alabama, including the development, implementation, installation and servicing of computer software and computer hardware.
3. The location of the initial registered office of the corporation shall be 350 Willow Glen Drive, Montevallo, Alabama 35115, and the name of its initial registered agent at that address is Warren E. Behling.
4. The authorized capital stock of the corporation shall be one thousand (1,000) shares having a par value of One and No/100 (\$1.00) Dollar per Share. The paid-in capital with which the corporation shall begin business shall be One Thousand and No/100 (\$1,000.00) Dollars.


6. The initial number of directors is two and their names and post office addresses are as follows:
