

ARTICLES OF INCORPORATION

OF

AN ALABAMA CORPORATION

The undersigned, whether one or more, in order to form a corporation under and pursuant to the laws of the State of Alabama, hereby adopt the following Articles of Incorporation:

1. NAME: The name of the corporation is Concord Medical, Inc.
2. PERIOD OF DURATION: The period of duration of the corporation shall be perpetual.
3. PURPOSES: The purpose for which this corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Alabama Business Corporations Act.
4. SMALL BUSINESS CORP.: This corporation will be operated as a small business corporation and will make an election pursuant to Subchapter S.
5. AUTHORIZED SHARES: The aggregate number of shares of stock which the corporation shall have the authority to issue shall be 25,000 shares of common stock of the par value of One


