KNOW ALL MEN BY THESE PRESENTS,

That in consideration of ONE HUNDRED THIRTY SEVEN THOUSAND AND NO/100 DOLLARS (\$137,000.00) to the undersigned grantor, DEBO CONSTRUCTION COMPANY, INC., a corporation, (herein referred to as Grantor), in hand paid by the Grantees herein, the receipt of which is hereby acknowledge, the said Grantor does by these presents, grant, bargain, sell and convey unto **JERRY A. DEES AND LINDA G. DEES**, (herein referred to as Grantees), as joint tenants with right of survivorship, the following described real estate, situated in the State of Alabama, County of SHELBY, to-wit:

Lot 8, according to the Survey of Meadow Brook Townhomes, Phase II, 2nd Sector as recorded in Map Book 22, page 4 A & B, in the Probate Office of Shelby County, Alabama. Mineral and mining rights excepted.

Subject to existing easements, restrictions, set back lines, rights of ways, limitations, if any, of record.
