That in consideration of ONE DOLLAR, (\$1.00), AND OTHER GOOD AND VALUABLE CONSIDERATION to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, ROBERT EUGENE JARVIS, a married man; DOUGLAS R. JARVIS a married man; LINDA D. JORDAN, a married woman; JEAN S. JARVIS, an unmarried woman; CHERYL J. HINTON, a married woman; CARLA J. JOHNSON, a married woman; and CEA J. PANNELL, a married woman, (herein referred to as GRANTORS) do grant, bargain, sell and convey unto LINDA D. JORDAN (herein referred to as GRANTEES for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, the following described real estate situated in SHELBY County, Alabama to wit:

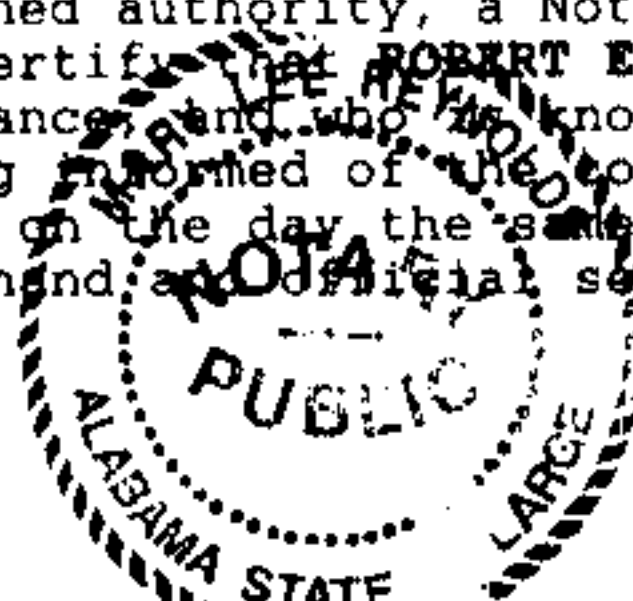

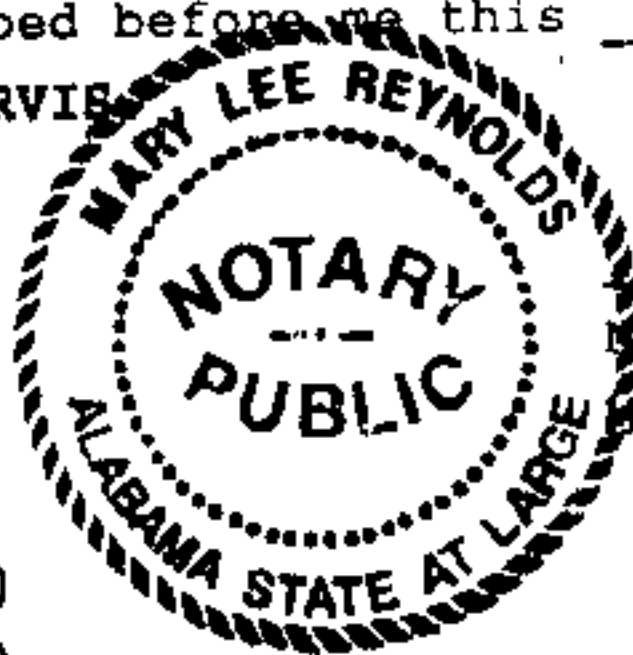
