## ASSIGNMENT OF DEVELOPER RIGHTS

Pursuant to Assignment of Developer Rights dated as of the date hereof and recorded contemporaneously herewith in the Probate Office, CWD has transferred and assigned to Assignor all of CWD's right, title and interest as "Developer" under the Declaration, the Articles of Incorporation and the Bylaws.

Contemporaneously herewith, Assignor has transferred, sold and conveyed to Assignee all of Assignor's interest in the Property. In connection with the transfer and conveyance of the Property, Assignor desires to transfer and assign to Assignee and Assignee desires to accept and assume all of Assignor's right, title and interest as "Developer" under the Declaration, the Articles of Incorporation and the Bylaws.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby transfer, assign, set-over, deliver and convey to Assignee all of Assignor's rights as "Developer" under the Declaration, the Articles of Incorporation and the Bylaws (collectively, the "Developer Rights"). Assignor does hereby accept and assume all of the Developer Rights. From and after the date hereof, all references in the Declaration, the Articles of Incorporation and the Bylaws to "Developer" shall mean and refer to Greystone Cove, LLC, an Alabama limited liability company, and all consents, approvals, rights, actions, obligations and responsibilities of Teveloper set forth
