KNOW ALL MEN BY THESE PRESENTS, That in consideration of **NINETY THOUSAND FOUR HUNDRED DOLLARS AND NO/100's (\$90,400.00)** to the undersigned grantor, **H.P.H. PROPERTIES, INC.**, a corporation, (herein referred to as **GRANTOR**), in hand paid by the **GRANTEES** herein, the receipt of whereof is acknowledged, the said **GRANTOR** does by these presents grant, bargain, sell, and convey unto **GEORGE PRESTON KAUFFMAN, III** and **BARBARA A. KAUFFMAN** (herein referred to as **GRANTEES**) as joint tenants, with right of survivorship, the following described real estate, situated in **SHELBY** County, Alabama:


