

ARTICLES OF INCORPORATION

OF

1. The name of the corporation is Cross Custom Homes, Inc..
2. The period of its duration is perpetual.
3. The purpose or purposes for which the corporation is organized are to engage in the general development of land, including the purchase and sale of real estate, improved and unimproved, to subdivide land into subdivisions or lots, to loan money on real property and to accept secured and unsecured notes as to collateral for the property; and to engage in any lawful act or activity for which a corporation may be organized under the Alabama Business Corporations Act.
4. The aggregate number of shares of capital stock which the corporation shall have the authority to issue is 1000 shares of common stock, par value of \$1.00 per share.

Purchases by the corporation of its own shares, whether direct or indirect, may be made to the extent of unreserved and unrestricted earned surplus and capital surplus of the corporation available therefor.
