KNOW ALL MEN BY THESE PRESENTS, That in consideration of FIVE HUNDRED FOURTEEN THOUSAND FIVE HUNDRED DOLLARS (\$514,500.00) to the undersigned grantor, TRINITY BUILDERS, INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto JAMES A. BRITAIN, JR. and CAROL M. BRITAIN (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:
